TO: Ontario Ombudsman

I am writing and filing this complaint on 2023-09-05 and I will be sharing it with the nation too see as I have received no response or help from the Ontario Ombudsman since I started filing complaints starting in 2018.

My life is in jeopardy because of an Ontario provincial police officer naming [REDACTED] and the Ontario Court of Justice in [REDACTED] Ontario whereas I have filed complaints about this issue already and the corruption continues.

I did not give permission for this Government to take power or control over me JENNYLYNN WOODCOCK whereas they have been for decades. This Government and all government workers have been infringing on the rights and freedoms of Trillions of Canadians for centuries and people need to be made aware of what is really happening.

On August 14<sup>th</sup> 2023 I filed a written complaint notifying the ONTARIO OMBUDSMAN about this officer who has been criminally stalking and harassing me and my children since we moved to Fenelon Falls in 2016 as well as the history of corruption that is taking place in the [REDACTED] Ontario Court of Justice.

I made the Ontario Ombudsman aware on August 14<sup>th</sup> 2023 through a written complaint that my rights and freedoms under section 7- Life, Liberty and security of a person were being infringed upon on May 15<sup>th</sup>, 2023, by this officer when he performed in an illegal stop violating my legal rights under section (8)- search and seizure. The Ombudsman was also made aware I was in court with this same officer on May 16<sup>th</sup> 2023 for a trial which is violating my legal rights under section (11)(d) - Proceedings in criminal and penal matters.

Given on August 14<sup>th</sup> 2023 when I filed my complaint and make the Ontario Ombudsman aware that my vehicle was impounded, and the charges were withdrawn in court on July 18<sup>th</sup> 2023 and an order to release my vehicle was signed on July 21<sup>st</sup> 2023 and my vehicle is still sitting in impound I would say the Ontario Ombudsman does not have the best interest for the citizens of this country and people need to be made aware of this so they can protect themselves from the corruption that is happening within our system.

I have filed many other complaints before the complaint on August 14<sup>th</sup>, 2023, whereas the corruption continues, I fear for my life, because of the [REDACTED] Ontario court of justice and the corruption taking place in that courthouse and this police officer who is friends with one of the judges. I do not have a criminal record so why am I being targeted by this Government?

Is it because I am using my voice and speaking up about the corruption and have since 2018? Is this the reason I am not receiving any help? Is this the reason why I am being targeted and the police, judges and crown prosecutors are allowed to get away with doing this to a single mother on Disability? I have questions I want answered because I am tired of my rights and freedoms being infringed upon by this Government when I did not give them the power over me.

Perhaps the people in this nation would like to know that on July 18<sup>th</sup>, 2023, the crown prosecutor ██████ admitted in the ██████ Ontario Court of Justice that our law enforcement officers have (6) months to come back and lay a charge on someone. This crown prosecutor is admitting the Criminal justice system is and has been infringing on the rights and freedoms of millions of citizens under section 11(a)(b)(d) - Proceedings in criminal and penal matters.

I contacted the BBB-██████████ about my vehicle that has been sitting in their impound yard for a total of 113 days since May 15<sup>th</sup> 2023 as they were made aware on July 18<sup>th</sup> 2023 the charges were withdrawn and all they would do is reduce the cost which to me is not fair considering I was stalked and harassed on May 15<sup>th</sup> 2023 by this officer which is a criminal offense under section 264(1) and I have been for 6 years. Because I contacted the BBB-██████████ on this company on FRIDAY SEPTEMBER 1<sup>ST</sup> 2023 I was re-summons to court by this officer with a court date of September 12<sup>th</sup> 2023 at 9:00am this again violates my legal rights under section 11(a)(b)(d) as well as my legal rights under section (7) life, liberty and security of a person.

First off, the occurrence happened 113 days ago, the charges were withdrawn in court on July 18<sup>th</sup> 2023 this is 49 days ago this I would say is the evidence this officer is breaking the constitution act here in Canada and being allowed to get away with it because he is protected by all the government workers which is not fair to the citizens of this country who pay the wages of these workers.

I am just one person, if the ██████ Ontario Court of justice is doing this to me, I could only imagine how many other people there doing the same thing too. I have been targeted by this court location since 2013 whereas I have filed a human rights application under section 34 of the human rights code because I am tired of being made a target for this Court location whereas I also mentioned this in my past and previous complaints made to the Ontario Ombudsman why is nothing being done?

Why is this officer still allowed to continue to patrol the streets when he targets innocent people who suffer with mental health problems whereas he is aware of this given I have been dealing with this officer in court for 6 years now, if this doesn't show the system the stalking and harassment he is engaging in then I would have to say the system is taking a blind eye to what is happening to defend this government. I as a Canadian citizen who needs to defend my brothers and sisters and make them aware of the corruption that has been happening a lot longer than just two years. Our system is broken and who are we to trust?

My children and I have lived for decades with this corruption and we have never received justice for what we have been put through so perhaps the people in this country would like to know this

government has been taking licenses away from Canadian citizens for years, police have been targeting the innocent while protecting the criminals and the system wants to put a single mother who is on disability in jail for driving to survive because the judges, crown prosecutors and legal aid lawyers stick together and target people. The government has been infringing on the rights and freedoms of people for longer than most people understand. I am here to make others aware of the truth seeing as I have not received any help. I have been filing complaints and providing the Ombudsman with evidence for the past 4 years. Given the amount of knowledge I have shared with the Ombudsman, and this is continuing I would say the Ombudsman does not have the best interest for the Canadian citizens of this country and are protecting the government in the crimes against humanity that is taking place.

I have lived for decades being targeted by both the provincial and federal levels of government because of my mental disability which was caused because I was being targeted by the police and children's aid society of Ontario for 19 years. Trying to take my kids away from me for years, accusing me of crimes I would never commit just to take my kids from me but not once could they because I gave up everything for both my kids and they could never prove me to be unfit. I should not have to sit here and explain my life story over again considering all of this has been mentioned before in other complaints made.

When is this government and the workers going to stand up for the people? The mental health crisis going on in our world is the governments' fault. On Friday September 1<sup>st</sup>, 2023, when constable [REDACTED] [REDACTED] showed up at my place of residence to issue me the Summons tickets for the May 15<sup>th</sup>, 2023, occurrence involving constable [REDACTED] she attended with a Canadian mental health worker naming [REDACTED] this is proof the police and the mental health officers work hand in hand. The Canadian mental health association is just another tactic for the police and the government to use to target people who are mentally unstable. These are the things my brother and sisters around this country need to be made aware of. The criminal justice system is all a money grab for taxpayers' dollars, and they work hand in hand with the ministry of transportation to target people. I fought for my driver's license back in 2018 after not having it for 10 years because I would not go on a date with a police officer.

I provided the HRTO – [REDACTED] a copy of (20) tickets I received from this officer and my application was dismissed. If this is not protecting the Government, I don't know what is!

I appealed \$29,000.00 in 2018 and two years later I now owe over \$18,000.00 because of the judges and crown prosecutors in the [REDACTED] Ontario Court of Justice targeting me, discriminating against me for winning my appeals.

I am tired of attending court, I have been attending court dealing with the [REDACTED] for a decade and I refuse to do it any longer. I will not be owned by this government or the corruption that is taking place in the criminal justice system. I will not be attending my upcoming court dates as I refuse to allow this government to have power over me or my two children [REDACTED].

This government has taken everything from the three of us, we are being forced to live in a rundown apartment whereas we receive no help from the Landlord, and I have been waiting for almost two years for a hearing date with the Landlord and tenant board of Ontario. In the meantime, I have to live in fear

of the animals that are running ramped through the walls of this old building are going to chew through wires and burn the place down. I cannot afford to move, and I have no means of transportation because the Lindsay Ontario Court of justice has robbed me of my license and the Ontario provincial police have stolen my vehicle that is sitting at [REDACTED] in [REDACTED] ON so this 15 minute cities have been happening long before the government announced to the people they were bringing this into effect.

The mental abuse this government is putting people through is unfair and needs to be stopped because this is not fair to the citizens of this country while the government protects other countries.

I as a citizen of Canada ON refuse to allow this government to make me feel like I am the problem or that I need help when the Government is the one who has created all my mental challenges that I have faced and continue to face. People all across this country need to know about what this government has been doing to the citizens of this country for longer than I have been alive.


